## Newtonhill, Muchalls and Cammachmore Community Council

## **Draft Minute**

The 366<sup>th</sup> meeting of Newtonhill, Muchalls and Cammachmore Community Council was held on Wednesday 20<sup>th</sup>September 2023 in the Skateraw Hall

PRESENT – Mr Flockhart (Chair), Mrs Stephen, Mr Ewing, Mr Cruickshank, Mr Jones, Mr Morgan, David Walton from Portlethen and District Community Ambulance, Councillor Victor and one member of the public.

Mr Flockhart welcomed all and thanked them for coming out on such a cold night

- 1 APOLOGIES Miss Daniels, Mr Chew.
- 2 POLICE REPORT No Police presence and no Police Report. Some crimes will not now be investigated by Police Scotland.
- 3 MINUTE 365 Accepted.
- 4 MATTERS ARISING
- (1)(4.4) Any response re Mr Morgan's letters re change to bus services. No response so far. Appears no-one interested (2) Mr Flockhart has contacted the Traffic Commissioner re cessation of bus services as a result of an accident on the A92 and the matter has now been sent to Bus Users Scotland. Mr Flockhart has received a request for further information. Mr Flockhart is hoping to organise a meeting of all concerned to find a solution to what happens when part of a road is closed due to an accident. Despite the fact Stagecoach have set routes they are not obliged to provide transport at all times.

Mr Flockhart would also like to raise the theory that due to teenagers having free transport, they are moving from their own areas to carry out vandalism elsewhere.

At this point Mr Flockhart introduced David Walton from Portlethen and District Community Ambulance. This provides free transport to those who need to access Portlethen Health Centre or dentist in Portlethen and who have no alternative means of transport. They are about to take delivery of a new vehicle in November. Community Council offered a donation of £100 which was gratefully received. Other sources of funding were discussed.

- (2)(4.5) SSEN Fund Awards due in October 2023. It was pointed out to Mr Flockhart that if kits are handed out, we would have to make sure they are returned. Perhaps recipients should be asked to sign for them.
- (3)(4.6) Bushes at St Ternan's see later

Repairs to Bridge at Burn of Elsick - see later

(4)(4 8) Scaffolding – The scaffolding has been demolished and is currently in the shed behind the Church. It does not look like the extra Christmas lights will be put in place this year. They are no longer required to prove public liability insurance but assume CC will still pay for cover for this. Matter appears to have been resolved.

(5)(14.30) Mr Flockhart attended the Community Council Forum where he took on the role of Chair. Well attended with several joining online. A questionnaire had been issued which had been practically unreadable and very difficult to decipher. Apparently, it had been issued due to time constraints although the person signing it off was not happy. Discussion followed with one comment being if you are clever enough to be a Community Councillor you should be able to read and decipher such a document. Unfortunately, not all people are good at reading and writing but are good at practical things.

Comments were made that Council documents are becoming more and more difficult to read and understand. Could we perhaps request that plain English is used?

- 5 PLANNING (1) Erection of Agricultural Building at Cranhill Farm, Cammachmore,
- (2) Aberdeenshire Local Development Plan 2023 Draft Supplementary Guidance on Developer Obligations and Affordable Housing Public Consultations, (3) Mr Morgan has drafted a response to the Soils Evidence Report. Also, Developer Obligations Guidance. Evidence Reports should be completed by November but as there are still approx. 30 reports to come, this seems very unlikely.
- 6- ROADS and POTHOLES Mr Flockhart has raised several points with Aberdeenshire Council
  - (a) Zig zag markings at Newtonhill Plan now in place for the zig zags If not completed by the end of October, then it will be next year due to the weather.
  - (b) Hedge at St Ternan's Owners were contacted by the Council some time ago. They have now received a reminder.
  - (c) Bridge at Burn of Elsick The bridge was badly damaged by flood waters. Necessary repairs will be carried out but as yet no definite date.
  - (d) Cammachmore Filter Lane grit, soil, weeds on filter lane southbound from A92. This is the responsibility of Aberdeenshire Council but would also involve Amey as the road would need to be closed. Could prove to be a costly job.
  - (e) Barratts sign at top of Newtonhill Road The Planning Enforcement team will investigate aiming to provide a response within 8 weeks. Still waiting for a response. Sign was removed after sales weekend
  - (f) Dyke at the Lomonds Further investigation of ownership is needed. A new safety barrier will be erected but who knows when. Mr Flockhart has also requested that the street light be repaired.
  - (g) Some of the smaller potholes in Muchalls have been filled. Also, some of the smaller ones in Newtonhill.
- 7 UNDERPASS No further information.
- 8 BINOCULARS/TELESCOPE Bill has been paid and delivery expected in a few days. Hopefully, all should be in place by the end of October. Thanks to Mr Jones for his hard work.

Walking maps have been received and delivered with the Newsey. Donation to be made to the Newsey (£200) from remainder of telescope money.

9 - FINANCE REPORT – CC grant has been received. Community Council approx. £1300; Binocular fund approx. £699 and Village stones approx. £2900.

- 10 CHAPELTON SCHOOL BUS This has temporarily been re-instated pending further investigation into the safety issues. Hopefully common sense will prevail. Thanks to Councillor Victor for all her persistence and hard work.
