- 2 MATTERS ARISING None.
- 3 CHAIR'S REPORT Good news first replacement of the bridge over the Elsick Burn and turning of kerbs in the area of the Courts.

Donations were given to several organisations.

Still trying to get the A92 underpass up and running and roads continue to give us problems.

Newtonhill School still having to deal with traffic issues due to increased traffic from Chapelton. Portlethen Health Centre is also having to deal with extra patients.

Office Bearers confirmed they are happy to stay as they are.

3 – POLICE REPORT – Written Report received for May 2025. Youth disorder 16; Anti-social 18; Shoplifting 6 detected, 2 under investigation; Careless driving 3 detected; Drink/drug driving 1 detected. Once again, we are included in the Stonehaven area.

More complaints re children riding electric bikes recklessly causing problems for residents as well as putting themselves at risk.

### 5 - MATTERS ARISING

- (1)(7) Paul Macari cannot attend June meeting and not sure about August. Mr Chew has submitted a list of questions to forward to Paul Macari for answers when he attends a CC meeting. Mr Flockhart has once again contacted Mr Macari re possible visit. Also, raised a query re Developer Obligations. Reply from Rob McIntosh (Principal Developer Obligations Officer). (a) Community Halls £164,246.20. All to go to the Bettridge Centre to create a multi-purpose room in the former basement/garage, (b) Healthcare £62,278.41. Discussions going on with NHS Grampian on how to spend, (c) Sports/recreation £47,301.30 (£10,000 to extend football pitch in Newtonhill. Some of remainder to go to create a pickleball court and restore existing tennis courts to increase their use still working on costing.) Expiry dates for funds 1-2-2031. No funds have been returned to the Developer.
- (2)(8.3) Joint meeting Still waiting.
- (3)(8.3) Pedestrian Walkway No progress.
- (4)(14.1) Councillor Conduct Appears not much we can do.
- (5)(14.3) Public Right of Way in the vicinity of Newtonhill Awaiting information on Public Right of Way.

- (6)(14.3) Newtonhill Library The transfer of Newtonhill Library out of LLA's portfolio refers to the portacabin, not the current library.
- (7)(14.14) White lines at St Crispin's Road/Elsick Place Ian Peacock will get back to Mr Flockhart once he has consulted with the Maintenance Team. Hopefully work will be carried out by end of June.
- 6 PLANNING (1) CC to write in support of development at Bettridge Centre but queries to be raised re drainage, new soak away, (2) Advertising sign for Chapelton Development has appeared at the Park and Choose. Can anything be done? (3) Garage at Oran, Newtonhill Is this a private garage or commercial garage?
- 7 CHAPELTON Several parents are sending their children to Lairhillock School. Lairhillock School is not in the catchment area for Chapelton. It is, however, a feeder for Mackie Academy. Pupils from Chapelton will feed to Mackie Academy as Portlethen academy will soon be over capacity.

Mr Flockhart commented on a change to relaying information at Chapelton Liaison meeting. Not so much information coming forward.

Several queries – How many houses have been sold? Why only one road in and out of Chapelton? What has happened to proposed hall for residents? Education – what is happening re new school? Why no connection to Cookney Road (because Aberdeenshire Roads Department says no).

Chapelton is within the NKRCC area. NKRCC has been updated with any information we receive.

Negotiations still ongoing re planned primary school and road access through and around Chapelton during the next stage of development.

Face to face meeting with NHS Grampian – Mr Flockhart still trying. Response from Scottish Government the place to register complaints against NHS Grampian is NHS Grampian. Mr Flockhart has now contacted Audrey Nicoll for advice.

## 8 - ROADS and POTHOLES-

- (1) No update on car dumped on Walker Drive. Aberdeenshire Council have acknowledged resident's complaint as 28 days have now passed.
- (2) Mr Flockhart trying to ascertain when works promised in September 2024 will be carried out. Should be carried out by end of July but this will depend on severity of other defects elsewhere.
- 9 FEATURE WALLS Cammachmore All residents to receive a leaflet setting out suggestions for proposed feature wall. All comments welcome. Miss Daniels and Mr Torrance have been working hard on this and notes will soon be ready for delivery.

Mr Connolly has already delivered notes to some parts of Cammachmore and half way round Durris.

Portlethen Golf Club has donated a round of golf for four people. Two donations received (£50 and £95).

Muchalls on hold at the moment due to some problems with design and massive increase in costs.

## 10 - FINANCIAL REPORT - £6,583

11 – TENNIS COURTS – Mr Morgan has contacted NVA who are hoping to redevelop the courts, etc. LLA are happy to lend support but no funding. Tennis nets are ok at the moment for a knock about.

Aberdeenshire Council is to be asked to trim back the trees to stop leaves etc damaging the surface of the tennis courts.

Mr Jones and Mr Morgan to attend the next NVA meeting and Mr Jones to enquire re possible funding from the Common Good Fund for upgrading of tennis courts. Do Christmas lights get any funding from Common Good Fund? Who does one approach for information?

Is there any update on when the information board will eventually be put in place at the field? Mr Jones once again to try his best with Aberdeenshire Council.

- 12 COASTAL PARK Aberdeenshire Council received a request for cricket pitch. There used to be a cricket pitch some time ago and a group would now like to see it resurrected. Appears there is no problem as enough room for cricket and football practices if needed. All football matches are now played in the park. Could developer obligations go towards this?
- 13 CERULEAN WINDS' ASPEN OFFSHORE FLOATING WINDFARMS Consultation event on  $11^{\rm th}$  June focussed mainly on the offshore elements. A further consultation will deal with onshore aspects.

Windfarm will be offshore at Peterhead and will possibly not be seen from here. Not sure where it will come on shore but will eventually link up to substation at Fetteresso. Possibly most will be underground but there will be further consultation. Should be operational by 2029/2030. Once route is published, we will make enquiries re possible benefits. Should funding application be made to the Office of the Crown Estates? A rep from Cerulean to be invited to a future meeting.

14 – NHS GRAMPIAN – Have had to borrow money from Scottish Government. Stonehaven Hospital losing X-ray facilities in 2026. Mr Morgan to contact NHS Grampian raising our concerns on what effects proposed cuts will have on patients esp those living near Stonehaven.

- (4) No plants from Aberdeenshire Council this year. Could the Newtonhill Allotments Group get involved in bringing on plants for next year? Mr Jones to contact Colin Pike to see if Portlethen Allotments Group can help.
- (5) Graffiti at football field has been cleaned. One end of portacabin has been painted. Donation of £100 is to be made towards purchase of paint. Discussion followed re possible solutions to graffiti.
